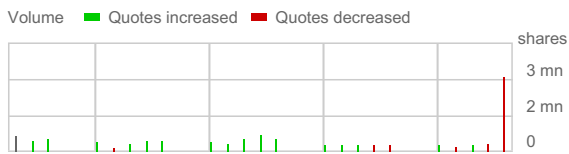
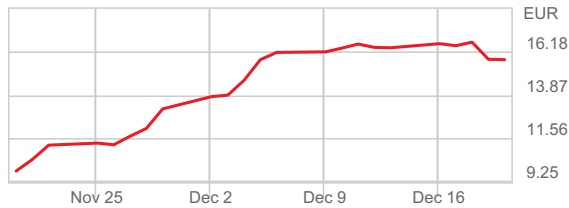


COMPANY PROFILE
