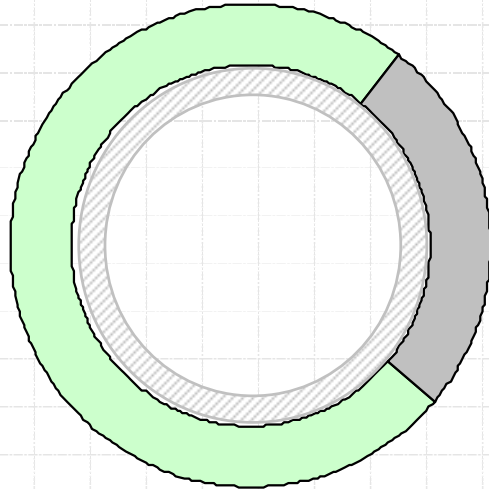

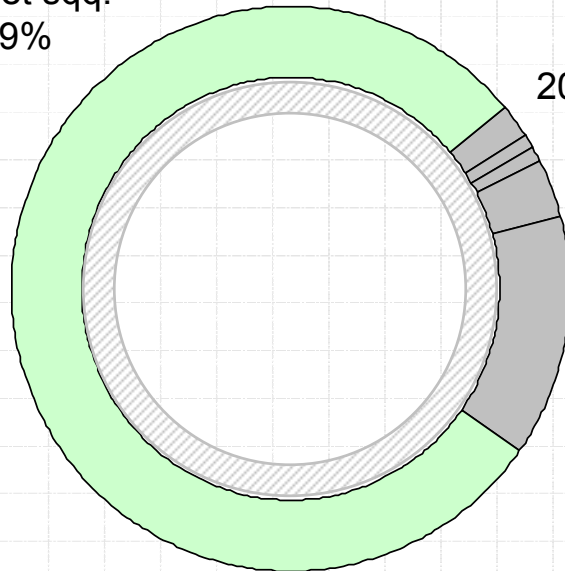

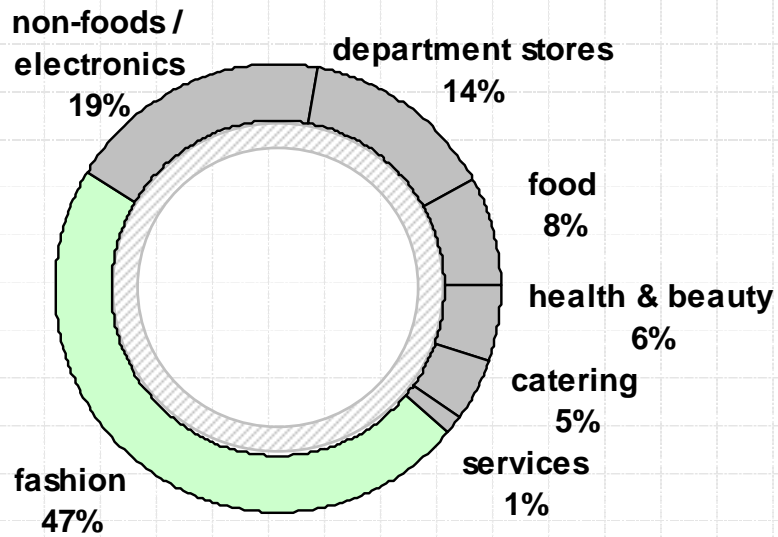

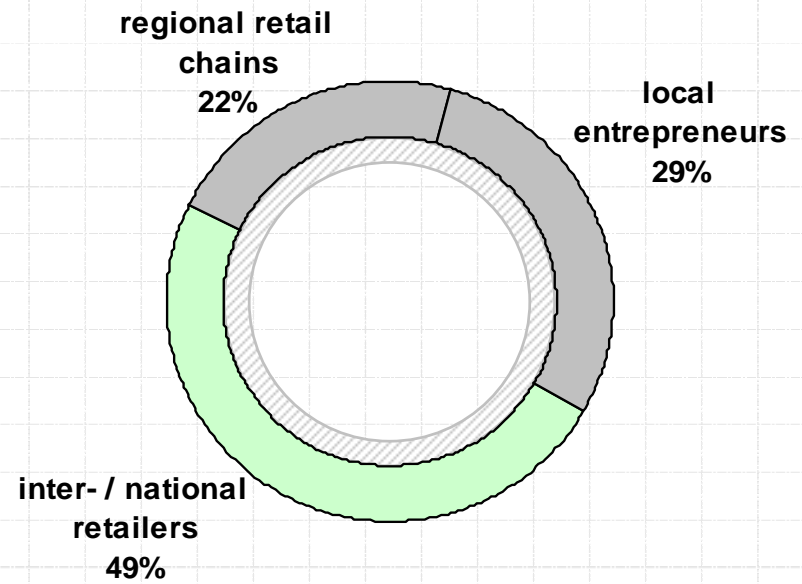
Maturity Distribution of Rental Contracts*

Balanced sector and retailer diversification

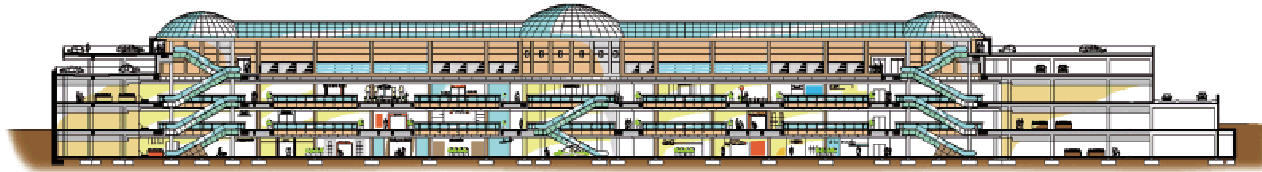

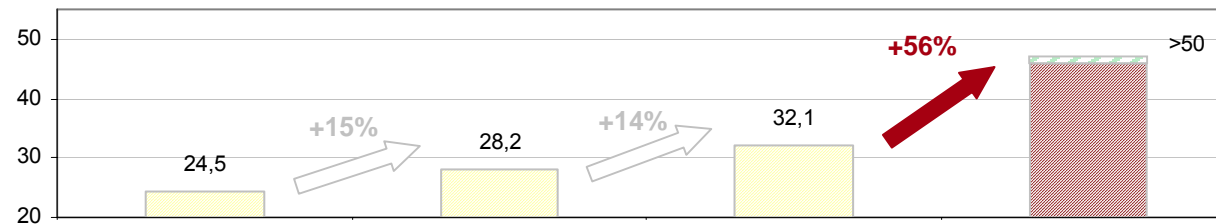
Revenue

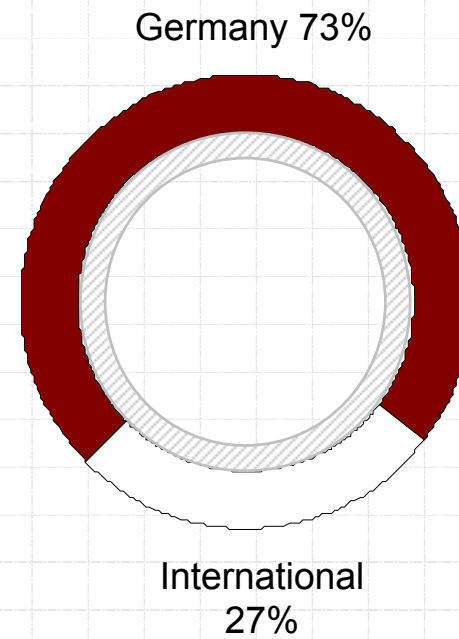

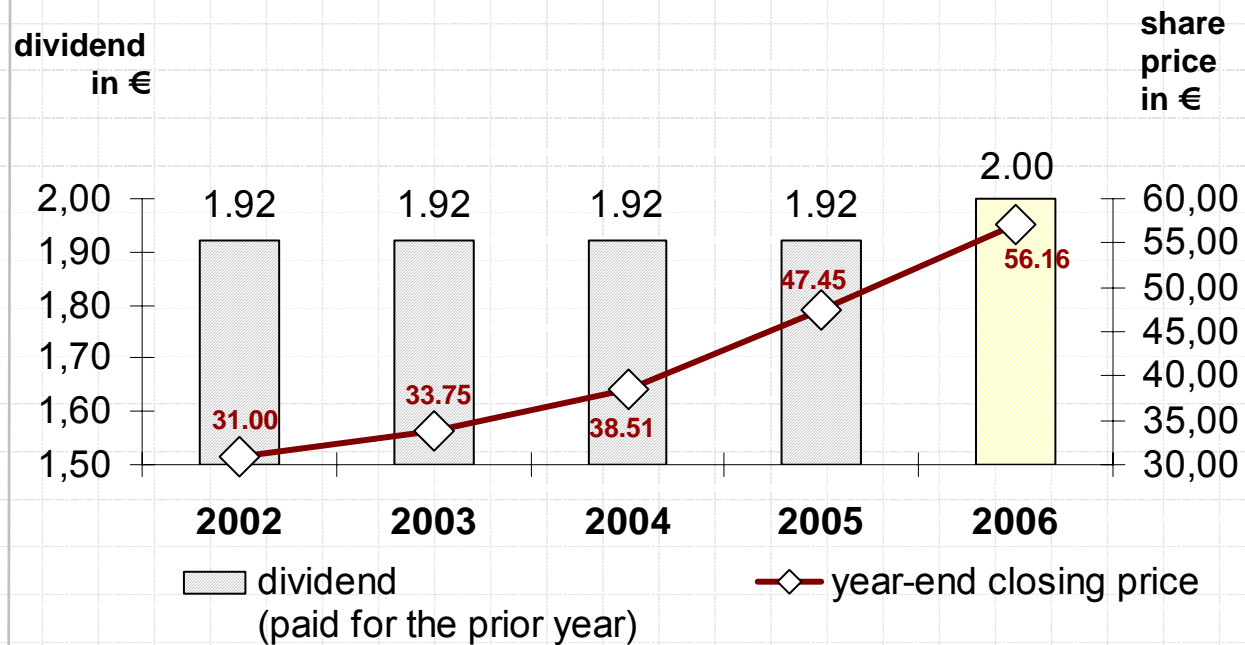
