# Interim report in accordance with § 37x of the German Securities Trading Law ("WpHG") for the first half of 2010



#### **Development of the business**

Your Family Entertainment AG (YFE) and the Australian producer of animated films, Ettamogah LMD Pty Ltd, have concluded a long-term agreement to cooperate in the worldwide distribution of initially four series of animated films outside Australia and New Zealand.

YFE introduced the German-language children's and family channel "yourfamily" in France at beginning of April 2010. "yourfamily" can initially be received in France via the IPTV platform "SFR". Negotiations are currently being conducted with distribution other partners. "yourfamily" is part of an exclusively German package of programmes assembled by the French distributor "Thema" that in addition to "your family" initially consists amongst others of programmes offered by ProSiebenSat.1, RTL und n-tv.

Your Family Entertainment AG is pressing ahead opening in up additional distribution channels. Together with Hutchison 3G Austria GmbH, it has introduced considerable success its own theme channel "Cosmo & Wanda" on Hutchison's mobile platform. additional single-theme channel is planned on this platform.

Your Family Entertainment AG was also able to conclude additional distribution partnerships. The expansion of the company's position in the highly dynamic middle eastern markets was emphasised by the conclusion of a major licensing package with "Al Jazeera".

In addition, a comprehensive and long-term partnership for several western European countries was concluded with "KidsCo".

#### **Profit situation**

The profit situation in the first quarter of 2010 was in line with expectations.

#### • Sales +16 %

Your Family Entertainment AG's sales increased by K-EURO 118 to K-EURO 849 in the first quarter (2009: K-EURO 731).

### EBITDA positive

A positive EBITDA was achieved at the end of March and is slightly above the previous year's level.

## <u>Dividend distribution for the past</u> financial year 2009

Following an additional successful financial year in 2009, Your Family Entertainment AG plans to make its first distribution of a tax-free dividend in the company's history as a listed company of 2 Euro cents per share.

The board of management and supervisory board will submit an appropriate resolution to the annual general shareholders' at its meeting on July 13<sup>th</sup> 2010.

Since this dividend represents from a tax point of view a benefit from the tax capital account in accordance with § 27 of the German Corporation Tax law, subject to the resolution of the shareholders' meeting the payment will be made free of tax.

## Outlook for the financial year 2010

Based on the previous years' positive results, 2010 will also be characterised by an intensification of the existing business segments.

Our activities will be focussed on the continued expansion of international distribution in the field of "license sales" as well as in obtaining new partners for our own "yourfamily" pay-TV channel.

The basis of Your Family Entertainment AG's business will be continually expanded by the addition of new productions to its library, such as for example "Oscar – The Balloonist", or through programmes as part of the distribution agreement with Ettamogah.

YFE's long-term goal is to recover its position as a strong international player in this market.
