Development of the business

The business development of Your Family Entertainment AG (YFE) continues to be characterised by the expansion of new distribution / sales channels in the ongoing business year 2010.

As well as the increasing demand in Eastern Europe and in the Middle East, growth in the German-speaking market was also recorded.

The expansion of coverage for the TV channel "yourfamily" was and continues to be these strategic focus. For this reason, the cooperation with the Baden-Wurttemberg based cable network operator Kabel BW was intensified.

Profit Situation

The sales revenue of Your Family Entertainment AG increased during the period of 1^{st} January to 30^{th} September 2010 by €277K (+17.1%) from €1,619K to €1,896K.

The EBITDA as of the end of September 2010 is positive.

The profit and liquidity situation meets expectations.
