It provides end-to-end online grocery fulfilment solutions to twelve of the world's largest grocery retailers and holds a 50% share of Ocado Retail Ltd in the UK in a Joint Venture with Marks & Spencer. Ocado has spent over two decades innovating for logistics and ecommerce, investing in a wide technology estate that includes robotics, Al and machine learning, simulation, forecasting, and edge intelligence.
- 2. Gavin Patterson served at Salesforce Inc. from 2019 to 2023, predominantly in the role of President and Chief Revenue Officer. Before joining Salesforce, he served as Group Chief Executive Officer of BT Group plc between 2013 and 2019. His prior positions include management and marketing roles at Procter & Gamble. Gavin has served on various boards including of listed, privately held and private equity-owned companies as well as for several charities and educational establishments. - 5. As Non-Executive Director of Ocado Group plc, Gavin Patterson will be paid a fee of £82,691 per annum, and an additional fee of £8,420 in respect of his membership of the Remuneration Committee, in line with the Directors' Remuneration Policy.
